If you live in a two-story home or apartment without elevator access, you may be charged an additional cost for the time spent negotiating stairwells. #### 8. Be familiar with insurance and value.

Any professional moving company must accept responsibility for the value of your possessions. However, like with any sort of insurance, there are various levels of coverage. It's critical to understand what your mover provides and how your belongings will be protected on the day of your move.

The most extensive coverage is full value protection. If your item is lost or damaged, the mover must either restore it to its original condition or replace it with a comparable item. They may also be able to pay for repairs or the purchase of a new item.

Alternative liability is a less expensive option, but its coverage is limited. The mover will accept an obligation of \$0.60 per pound for each article, based on the weight of the articles. This means that loss or damage claims are compensated based on weight rather than the dollar amount. Just in case, ask questions to ensure you understand how your items are protected.

#### 9. Execute a thorough contract

Many of the preceding suggestions boil down to this: make certain that all of the specifics are adequately covered and that your contract takes everything into consideration. If you discussed a specific component of your move with the moving company, be sure it is included in any contract you sign. Make certain that their fees are transparent and that the contract includes an itemized breakdown of everything that is covered.
